**Sub.: Extension of temporary approval of affiliation of Chanakya Law College, Rudrapur, Uttarakhand for 5 year BBA. LLB law course.**

Sir,

Legal Education Committee at its meeting held on 3<sup>rd</sup> March, 2012 considered the inspection report of the above mentioned college and Committee made the following recommendations:-

The college was earlier granted approval for 5 year integrated B. A. LL.B. course till the academic session 2011-12. Now, they have applied for closing down the B. A. LL.B. and for starting 5 year integrated B. B. A. LL.B. Committee considered the inspection report submitted by the inspection team of the Bar Council of India and approved the same subject to the compliance of the following:

1. They must continue the BA.LLB course which had approval already granted and complete the course and those students already been admitted can complete their course. No further admission to be made in BA.LLB course from the academic year 2012-13. So far fresh request for starting 5 year integrated B. B. A. LL.B. is concerned approval of affiliation is granted with intake of two sections of 60 students in each section for a period of two academic years i.e. for the academic session 2012-2013 and 2013-2014 subject to the following conditions:
  - a. The college shall purchase library books worth 60-70 thousand more every year.
  - b. Endeavour should be made by the college for participation of students in National level Moot court competition.



Compliance of the above conditions be submitted to the Bar Council of India by way of an affidavit within a period of three months.

The above recommendations were considered by the Bar Council of India at its meeting held on 15<sup>th</sup> April, 2012 and accepted the same.

College authorities are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31<sup>st</sup> December, 2013.
